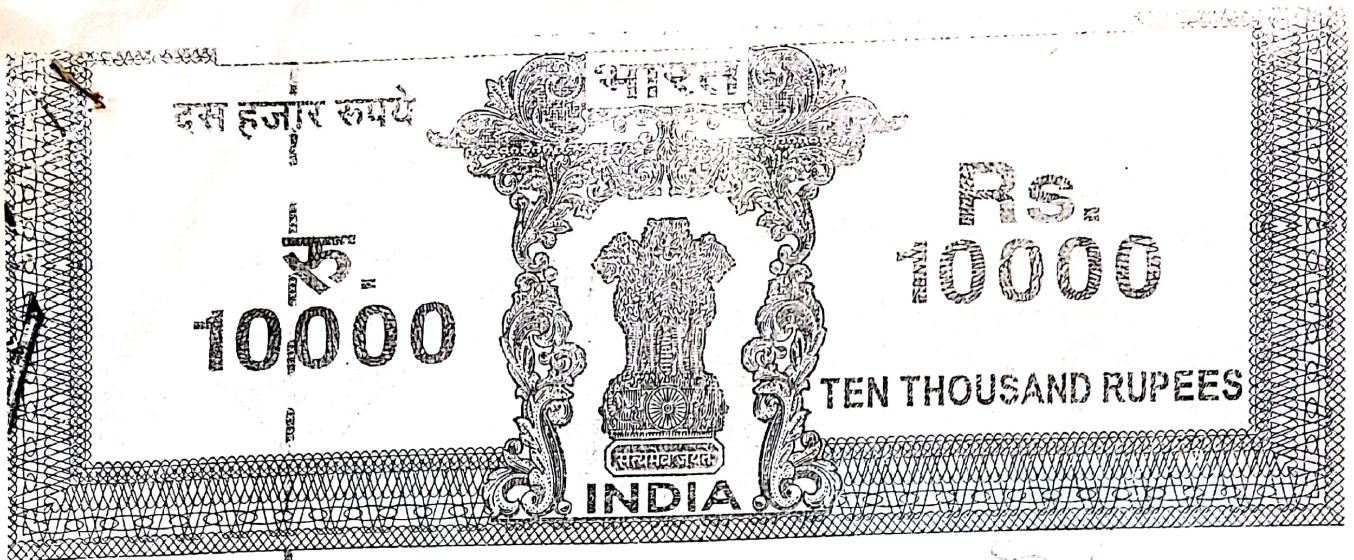

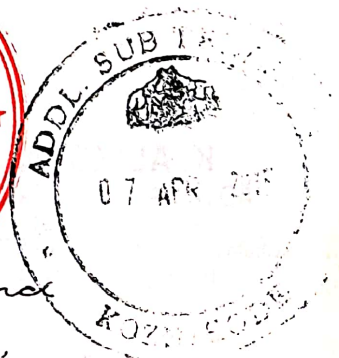

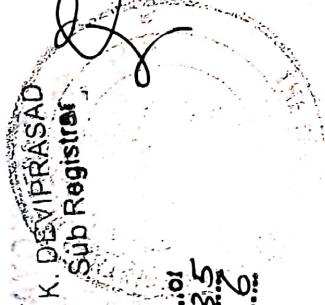

Bava Charitable Trust** which expression, where the context so admits shall mean and include his successors in office and representatives and assigns

WHEREAS the above Chairman herein along with Arakkal Pandikasala Unniyathankutty alias Bava Haji, Arakkal Pandikasala. Mohamed Koya, Alikkakath Mohamed Haneefa, had executed a Public Educational and Charitable Trust in the name of "**Haji A.P. Bava Charitable Trust**" with the address Chaliyam, Kozhikode and office of the trust at A.P.B House, Chaliyam, Kozhikode- 673 301 (hereinafter called the principal trust deed) and functioning for the main purpose of education and other purposes with the charitable object and for the purposes which is evidenced and described in the principal trust deed dated 24-12-2003 and registered as document No. 283 of 2003 vide Book IV, Volume 144 pages 39 to 44 of SRO Feroke.

WHEREAS while so the above said Arakkal Pandikasala Unniyathankutty alias Bava Haji, Arakkal Pandikasala Mohamed Koya were died and consequent to the death of the above persons the existing members of the trust nominated the new trust members hereunder and finalized the following decisions for the smooth management of the trust activities.

WHEREAS for the purpose of facilitating and implementing the purposes or objects, the above named Arakkal Pandikasala Unniyathankutty alias Bava Haji had delivered a sum of Rs. 70,000/- (Rupees Seventy Thousand Only), Arakkal Pandikasala Abdul Kareem, myself, Arakkal Pandikasala Muhammed Koya and Alikkakath Mohamed Haneefa had delivered a sum of Rs. 10,000/- (Rupees Ten Thousand Only) each, as investment to the trust for the time being for the objects as stated in the principal trust deed.

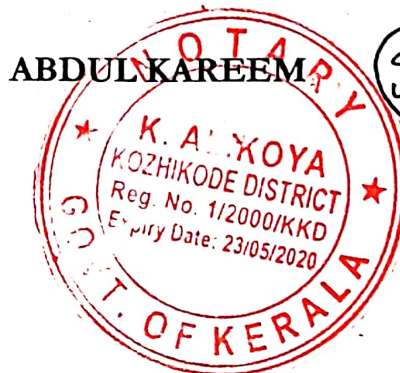

WHEREAS the Board of Trustees had convened a meeting held at the office of the trust on 1-1-2011 are of the opinion that an amendment to be carried out in the existing trust deed for the proper functioning of the trust and that effect the new Board of trustees of the said trust authorized the above said **ARAKKAL PANDIKASALAKKAL ABDUL KAREEM**, the Chairman of the said trust to execute this deed of amendment and the same was endorsed in the minutes accordingly as prescribed by statute.

NOW THEREFORE THIS DEED OF AMENDMENT TO THE TRUST DEED WITNESSES AS FOLLOWS:

WHEREAS all members of Board of Trustees at the meeting of the Board of Trustees held at its office on 1-1-2011 were unanimously passed a resolution to amend certain clauses and due to the changes made in the Income Tax Act to make it wholly charitable in view of the amendment.

1. The 2nd paragraph and point (a) in page no.5 of the principal deed shall be substituted by the following paragraph.

“ a) To establish educational institutions in India as per the majority decision of the Board of Trustees.”

2. The following para Nos. 13, 14, 15, 16 and 17 are inserted with effect from the date of the amendment.

13. The activities of the trust and its objects will be confined only to India.

14. The Trust is for the benefit of the public at large without any discrimination of any caste, community, creed, colour or religion.

15. The trust will not embark on any business nor activity unrelated to its objects. There will be no profit motive, whatsoever and all its activities would be prompted solely by service motive.
16. If any of the objects above is found to be inconsistent with the object of public charitable institution exempt formerly under section 10(22), (22A) and now under section 10(23C) or 11 of the income-tax Act, 1961 or any other law applicable to public trust as now enacted or as may be amended from time to time, or any new enactment relating to public trusts, they will be treated as modified to accord with such law.

17. Dissolution:

In case it becomes necessary to wind up or otherwise determine this Trust for whatever reason, neither the Founder nor his heirs nor the Trustee (s) for the time being nor any other person shall have any manner of right over such funds of the Trust or any other property.

The net funds and other assets, if any, after meeting all liabilities will be handed over to any other similar Trust or Institution similarly satisfying requirements of the Income-tax Act, 1961 as may be decided by the last Trustees subject further to the condition that it shall be so given to an Institution as approved by the Commissioner of Income-tax/Director Exemption or to the Government as the case may be.

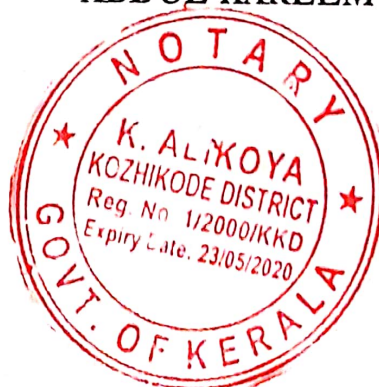
It has therefore become necessary for the sake of the said principal trust deed that the above said amendments to be carried out to the said principal trust deed as described above.

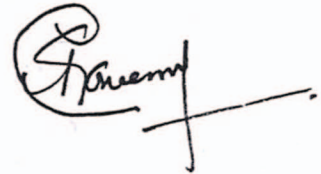
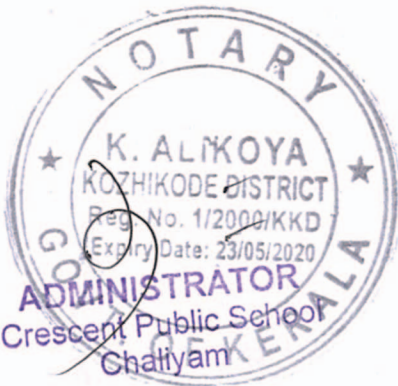
