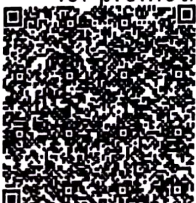

2. That the HAJEE A P BAVA CHARITABLE TRUST is of Non-Proprietary Character.

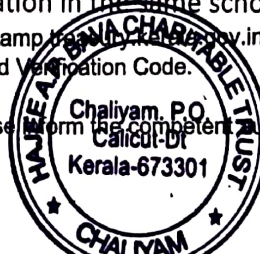
3. That the school is being run as community service and not as a business and that commercialization does not take place in the school in any manner whatsoever.
